Narrative:

On December 13, 2022, I made contact with Joshua and obtained a recorded statement regarding an incident that occurred on 12/10/2022. While providing his statement on a separate incident, Joshua wished to pursue charges against Michael Brown for threatening to assault and murder Joshua. Joshua provided me with a statement by email. Joshua stated these threats occurred on 04/25/2021 in front of his residence (16 Boerne Stage Airfield Rd, Boerne, TX 78006). Joshua also provided me with a photo of the incident.

Based on Joshua's statement, Joshua was walking home when he noticed a large number of people in front of his property. Joshua states Michael Brown was with the people in front of his home and appeared agitated. Joshua asked Michael what was wrong, which seemed to make Michael more upset. Michael then began to speak about other neighbors, and Joshua attempted to defend the neighbors Michael was speaking about.

At this point, Michael began to threaten to assault and murder Joshua. Michael took a fighting stance and then said he was getting his gun from his vehicle. Michael walked out of his vehicle but then stopped and walked back toward Joshua.

In conclusion, the elements to meet Terroristic Threats **PC 22.07** have been met: Michael Brown threaten to assault and murder Joshua.
