**AWARD AND JUDGMENT ON TOWED/REMOVED VEHICLE**

On the Date hereinafter written, came to be heard the above administrative matter. Vehicle owner or operator (did or did not) 2-17-22 appear. Respondent (did or did not) amended appear. The Court conducted an administrative hearing pursuant to Texas Occupation Code, Section 2803.458.

**FINDINGS OF FACT AND CONCLUSIONS OF LAW**

- (1)        Probable cause existed for the removal and placement of the vehicle in storage, and the vehicle owner or operator shall pay the costs of the removal and storage, plus costs of court, if any;
- (2)   ✓   Probable cause did not exist for the removal and placement of the vehicle in storage, and the person or law enforcement agency who authorized the removal and storage shall pay the costs of the removal and storage of the vehicle, or shall reimburse the vehicle owner or operator for the cost of the removal and storage paid by the vehicle owner or operator, plus reasonable costs of any photographs submitted as evidence, plus costs of court, if any;
- (3)        A towing charge imposed or collected in connection with the removal or placement of the vehicle was greater than the amount authorized by the political subdivision under Tex. Occup. Code, Section 2308.201 or 2308.202;
- (4)        A towing charge imposed or collected in connection with the removal or placement of the vehicle was greater than the amount filed with the Texas Department of Licensing and Regulation under Tex. Occup. Code, Section 2308.206;
- (5)        The vehicle owner or operator's written Request for Hearing was not filed in full compliance with Tex. Occup. Code, Section 2308.456. Request for Hearing.
- (6)   ✓   Attorney's Fees: \$       .
